Notice of Disqualifying Offenses

1. The Village of Glendale Heights shall deny participation in any Village youth program to a person who has been convicted for committing attempted first degree murder or for committing or attempting to commit first degree murder or a Class X felony or any one or more of the following offenses: (i) those defined in Sections 11-6, 11-9, 11-14, 11-15, 11-15.1, 11-16, 11-17, 11-18, 11-19, 11-19.1, 11-19.2, 11-20, 11-20.1, 11-21, 12-13, 12-14, 12-14.1, 12-15 and 12-16 of the "Criminal Code of 1961" [720 ILCS 5/11-6, 720 ILCS 5/11-9, 720 ILCS 5/11-9.1, ILCS 5/11-9.2, ILCS 5/11-14, ILCS 5/11-14.1, ILCS 5/11-15, ILCS 5/11-15.1, ILCS 5/11-16, ILCS 5/11-17, ILCS 5/11-17.1, ILCS 5/11-18, ILCS 5/11-18.1, ILCS 5/11-19, ILCS 5/11-19.1, ILCS 5/11-19.2, ILCS 5/11-20, ILCS 5/11-20.1, ILCS 5/11-21, ILCS 5/12-13, ILCS 5/12-14, ILCS 5/12-14.1, ILCS 5/12-15, ILCS 5/12-16, ILCS 5/12-21.6 and ILCS 5/12-33]; (ii) those defined in the "Cannabis Control Act" [720 ILCS 550/1 et seq.] except those defined in the "Illinois Controlled Substances Act" [720 ILCS 570/100 et seq.] and (iv) any offense committed or attempted in any other state or against the laws of the United States, which if committed or attempted in this State, would have been punishable as one or more of the foregoing offenses. Further, the Village of Glendale Heights shall deny participation in any Village youth program to a person who is a Registered Sex Offender [730 ILCS 150/1 et seq.] or who has been found to be the perpetrator of a sexual or physical abuse of any minor under 18 years of age pursuant to proceedings under Article II of the Juvenile Court Act of 1987 [705 ILCS 405/2-1 et seq.].
2. The Village of Glendale Heights shall deny participation in any Village youth program to a person for whom a criminal background investigation has not been initiated.
3. The Village of Glendale Heights reserves the right to examine arrests for the preceding offenses, where no conviction has been entered, on an individual basis for the purpose of determining an applicant's eligibility for the position applied for.
